All units involved are invited to attend. There will be plenty of activities including a banquet, a surprise TV actor guest, a day at Fort Carson, with a Memorial Service at the Fort, complete with a 21 Cannon Salute on the 21st of March for our Brothers who were lost on that day and during the insertion into GOLD on the 19th. A tentative guided tour of the Air Force Academy is in the planning stages. In addition, optional trips to Wildwood Casino are being planned. There will be plenty of things to do, a luncheon/shopping for the wives, a special guided tour of the Air Force Academy, and the best part is that you can be with all your brothers, see old comrades and make new friends. ### **Submitted by Editor—Whitewash/Blackwash—Myths of the Vietnam War**

#### **Myth #1—The US had no reason to be involved in Vietnam.**

The Cold War, a face-off between the Western powers and Soviet-based Communism, erupted into view shortly after the end of World War Two, and ended with the collapse of the Soviet Union in 1991. It is not easy for those who did not live in those times to understand the degree of concern that gripped the United States and many other countries during the 1950s and early 1960s. A long list of countries (Estonia, Latvia, Lithuania, Poland, Romania, Bulgaria, Czechoslovakia, East Germany, China, etc.) had been taken over by communists, using subterfuge, destabilization, and outright force, and the stated aim of international communism was to achieve world domination. A premier of Russia pounded a table in the UN and proclaimed to the American public “We will bury you!” With the Soviet bloc right on the borders of Europe, and China threatening Asia, the vision of a world possibly overrun by the Reds seemed all too real; and the reports from refugees of what life under Communism was like were more than enough to make Americans anxious to prevent that vision from ever coming true. The primary strategy of the US was the Containment Policy, whereby the US and its allies would do everything possible to prevent the continued takeover of countries by Communism. It was hoped/believed that over time the communist system would fall prey to inherent flaws and eventually fall apart. Communist insurgencies in Greece, Malaysia, Indonesia, and parts of South America were defeated, and South Korea was freed from the invasion by the communist North in a bloody war that was supported primarily by American troops. The atrocities committed by the communist troops, insincere and manipulative negotiations by the North Koreans, and horrific treatment of POWs were all aspects of communist actions that foreshadowed Vietnam. Early in John F. Kennedy’s presidency a crisis arose with a communist threat of missiles based in Cuba. This was resolved by brinkmanship diplomacy, but it served to maintain the resolve of the US to support the Containment Policy. Thus the threat of communists taking over all of Vietnam, which America had become well aware of during the 1954 division of that country as the French abandoned their imperial policy, was seen as the next incursion of expansionist Communism. And logically, the next place where every means had to be brought to bear to limit that incursion. The possibility that the other countries of SE Asia would then suffer communist subversion and eventual takeover was called the Domino Theory. While arguments have been made that the situation might have been handled differently, the resistance to the spread of Communism into Southeast Asia was entirely consistent with Containment. Since Laos and Cambodia share borders with Vietnam, and also border on Thailand, which borders on Malaysia, the avenues for the possible spread of communism across the region were obvious. Therefore, it is a myth that the USA had no stake in Vietnam, no real interest in the conflict.
