

Submitted by Editor—Hosting Guidelines

Rules for hosting a reunion from the By-Laws:

- A. Select a committee to assist in scheduling and arranging the reunion and regular membership meetings in accordance with the vote and desires of the membership as expressed at the previous regular meeting.
- B. Schedule and arrange for the meeting place accommodations to include business meetings, meeting and hospitality rooms, and public address systems. Arrange for social activities to include membership dinner, family recreational activities, and any other activities that might promote the success of the reunion.

While the organization is working on a written guide for reunion hosts and those considering being one, it is still in progress and not available. The basis of the guide will be an outline of all the elements that were present in our most successful reunions in the past, which are as follows:

1. Secure a venue providing shelter, kitchen and restrooms with handicap access.
2. Contract with a caterer to provide meals.
3. Contract with local talent for evening entertainment.
4. Negotiate discounted lodging with local hotels, motels and campgrounds.
5. Arrange special event(s).
6. Provide time and facilities for business meeting and Memorial Service.
7. Procure donated items for the raffle.
8. Conclude reunion with raffle and final evening of entertainment.

The outline was put together when we were meeting at rental halls. With the option of hotel based reunions, it would have to be adapted. The intention of the outline is to show how simple hosting can be when broken down into parts, rather than a strict blueprint.


1SG Johnny Larry, Jr. (67) - 4-70/71—1SG (Ret) Johnny Larry, Jr. of Bascom, Florida passed away September 20, 2016 at his residence surrounded by his loving family. On April 23, 1968 he was drafted at the age of 18 years old to the United States Army, where he served for 23½ years and retired, as 1SG.

David Van Johnson (71) - 1st Platoon 7-69/70—David Van Johnson of Baytown, Texas was born June 23, 1946 in Los Angeles, CA and departed this earth on January 21, 2018. His most notable accomplishments besides that of his family, were his service to his country during the Vietnam War, 1969-1971, rank SFC E7, then 28 years in the US Army Reserve before retiring. While serving in the reserve and other entrepreneurial activities, he was employed by Southern/Union Pacific Railroad from 1974-2010 and worked his way up to conductor.
