Without the numbers it is hard to plan, so the sooner you can send us the information, the better we can plan for our great reunion!

Here is the latest information and rates for the motels. I urge everyone to get their reservations in quickly. To get the negotiated group rate, make sure you say that it's for **Bravo Reunion 2012**. This is a tourist area and the motels fill up pretty fast. It's basically a "first come, first served" basis. Both Oxford Suites and Quality Inn will not increase the rate during the weekend, but Quality Inn will require a 4 night minimum stay to get the reduced weekend rate. Both Oxford Suites and Quality Inn have agreed to honor the negotiated group rate for a day or two before and after the reunion date. Motel 6 and the RV Parks and Campgrounds would not give us a group rate and their rates may change by 9/12.

My name is Kenneth Neveaux. I was in the battle at Firebase Crook as a Platoon Sergeant in B Co. I arrived in Feb., 1969. Our Company Commander was Captain Thomas. We moved from FSB Washington to FSB Crook to patrol the Cambodian border. At about 2 a.m. on the morning of the 6th, Captain Thomas visited each bunker and alerted everyone on what was about to happen. Like the article stated, at 3 a.m. we began three days and nights of incredible battle which I will never forget. We watched them dig fox holes and move close enough to where they were trapped between us and the artillery on the wood line. They came close to getting into the compound, one strand of wire away. They were trained NVA's and we were trained American soldiers. Everyone did a great job those three nights, holding our ground. Interesting Veterans Statistics of the Vietnam Memorial Wall

There are 58,267 names now listed on that polished black wall, including those added in 2010. ... The names are arranged in the order in which they were taken from us by date and within each date the names are alphabetized. ... Beginning at the apex on panel 1E and going out to the end of the East wall, appearing to recede into the earth (numbered 70E—May 25, 1968), then resuming at the end of the West wall, as the wall emerges from the earth (numbered 70W—continuing May 25, 1968) and ending with a date in 1975. Thus the war's beginning and end meet. The war is complete, coming full circle, yet broken by the earth that bounds the angle's open side and contained within the earth itself. ... The first known casualty was Richard B. Fitzgibbon, of North Weymouth, Mass. Listed by the U.S. Department of Defense as having been killed on June 8 1956. His name is listed on the Wall with that of his son, Marine Corps Lance Cpl. Richard B. Fitzgibbon III, who was killed on Sept. 7, 1965. ... There are three sets of fathers and sons on the Wall. ... 39,996 on the Wall were just 22 or younger. ... 8,283 were just 19 years old. ... 33,103 were 18 years old, the largest age group. ... 12 soldiers were 17 years old. ... 5 soldiers were 16 years old. ... One soldier, PFC Dan Bullock, was 15 years old. ... 997 soldiers were killed on their first day in Vietnam. ... 1,448 soldiers were killed on their last day in Vietnam. ... 31 sets of brothers are on the Wall. ... 54 soldiers attended Thomas Edison High School in Philadelphia, so many from one school. ... 8 women are on the Wall. ... 244 soldiers were awarded the Medal of Honor during the Vietnam War; 153 of them are on the Wall. ... Beallsville, Ohio, with a population of 475, lost 6 of her sons. ... West Virginia had the highest casualty rate per capita in the nation. There are 711 West Virginians on the Wall. ... The Marines of Morenci—they led some of the scrappiest high school football and basketball teams that the little Arizona copper town of Morenci (pop. 5,058) had ever known and cheered. They rode horses along the Coronado Trail, stalked deer in the Apache National Forest. And in the patriotic camaraderie typical of Morenci's mining families, the nine graduates of Morenci High enlisted as a group in the Marine Corps. Their service began on Independence Day. 1966. Only 3 returned home. ... The buddies of Midvale — LeRoy Tofoya, Jimmy Martinez and Tommy Gonzales were all boyhood friends and lived on three consecutive streets in Midvale, Utah on Fifth, Six and Seventh Avenues. They lived only a few yards apart they play ball at the adjacent sandlot ball field and they all went to Vietnam. In a span of 16 dark days in late 1967 all three would be killed Leroy was killed on Wednesday, November 22 the fourth anniversary of John F. Kennedy's assassination. Jimmy died less than 24 hours later on Thanksgiving day, Tom was shot dead assaulting the enemy on December 7 Pearl Harbor Remembrance Day. The most casualty deaths for a single month was May 1968 2415 casualties. For most Americans who read this. they will only see the numbers that the Vietnam War created. To those of us who survived the war and to the families of those who did not, we see the faces and feel the pain that these numbers created. We are until we to we to pass away, haunted with these numbers because they were our friends, fathers, husbands, wives, sons and daughters. There are no noble wars just noble warriors.
