Submitted by Joy Shipley (Honorary Member) - What Doctors Have Learned About COVID-19.

A professor of pharmacy at U of Toronto sent this clearly worded update to his family. For this pandemic, there's a greater chance of survival for those getting infected three months later like June 2020 than those who got infected three months earlier, say February 2020. The reason for this is that doctors and scientists know more about COVID -19 now than three months ago and hence are able to treat patients better. I will list five important things that we know now that we didn't know in February 2020 for your understanding. 1) COVID-19 was initially thought to cause deaths due to pneumonia—a lung infection—and so ventilators were thought to be the best way to treat sick patients who couldn't breathe. Now we are realizing that the virus causes blood clots in the blood vessels of the lungs and other parts of the body and this causes reduced oxygenation. Now we know that just providing oxygen by ventilators will not help. We have to prevent and dissolve the micro clots in the lungs. This is why we are using drugs like Aspirin and Heparin (blood thinners that prevent clotting) as a protocol in treatment regimens in October 2020. 2) Previously patients used to drop dead on the road before reaching a hospital due to reduced oxygen in their blood. This was called HAPPY HYPOXIA—where even though the oxygen saturation was gradually reducing, the COVID-19 patients did not have symptoms until it became critically less, like sometimes even 70%. Normally we become breathless if oxygen saturation reduces below 90%. This breathlessness is not triggered in COVID patients so we were late in getting sick patients to hospitals in February 2020. Now since knowing about happy hypoxia, we are monitoring oxygen saturation of all COVID patients with a simple home use pulse oximeter and getting them to the hospital if their oxygen saturation drops to 93% or less. This gives doctors time to correct the oxygen deficiency in the blood and there is a better survival chance in October 2020. 3) We did not have drugs to fight the coronavirus in February 2020. We were only treating the complications caused by it—hypoxia. Hence most patients became severely infected. Now we have two important medicines—FAVIPIRAVIR & REMDESIVIR. These ANTIVIRALS can kill the coronavirus. By using these two medicines, we can prevent patients from becoming severely infected and therefore cure them BEFORE THEY GO TO HYPOXIA. This is knowledge that is available in October 2020—not in February 2020. 4) Many COVID-19 patients die not just because of the virus but also due to the patient's own immune system responding in an exaggerated manner called CYTOKINE STORM. This stormy immune response not only kills the virus but also can kill the patients. In February 2020, we didn't know how to prevent it from happening. Now in October 2020, we know that Steroids, that doctors around the world have been using for almost 80 years, can be used to prevent the cytokine storm in some patients. 5) Now we also know that people with hypoxia become better just by making them lie down on their bellyknown as prone position. Apart from this, a few days ago Israeli scientists have discovered that a chemical known as Alpha Defensin produced by the patient's white blood cells can cause the micro clots in blood vessels of the lungs, and this can be treated with Colchicine which has been used over many decades in the treatment of gout. So now we know for sure that patients have a better chance at surviving the COVID-19 infection in October 2020 than in February 2020. Going forward there's nothing to panic about COVID-19 if we remember that a person who gets infected now has a better chance at survival than one who got infected early. Let's continue to follow precautions, wear masks and practice social distancing.

Joseph Leo Stein, Jr. (3rd Platoon—9/66-67 Original)

To the people that knew him, Joe was a man with a big heart and a passion for life. For the last several years, Joe's heart and passion battled back from several illnesses but each bout left him a little weaker, but he kept on fighting. On Sunday, August 30, 2020, Joe's big heart was just too weary to carry on the fight. Joe was born in St. Louis County and was a longtime resident in Bridgeton, Missouri. After his retirement, Joe and Judy sold the Stein family home and moved to Wentzville, Missouri where he resided until his death. Joe and Judy would have celebrated their 50th wedding anniversary on November 28th. Joe started working for General Motors directly out of high school and worked there for over 30 years, except for the time that he spent in the military. He was drafted into the Army where he served in Vietnam during 1966-1967 in Bravo Company, 3rd Battalion, 22nd Infantry. Joe enjoyed wintering in Florida, spending time fishing with the grandkids, golfing and woodworking.

Jack Zuverink (F.O. RTO- 2/67-7/67—Reported by his daughter, Jessica Harper

My father, Jack Zuverink, passed away on August 22, 2020. The world lost another Vietnam veteran, his brothers lost a fallen brother-in-arms, his family lost a brother, father and a husband. My brothers and I lost our hero, our father and the man that raised us. Our father touched so many lives ,fought for so many veterans to be recognized, or to get the benefits they deserved. Between American Legion, VVA, and DAV in the upstate, not one person can say they don't know who Jack Zuverink was. He was the man that got monuments placed in Walhalla, he was the man you went to for answers My father was a proud Vietnam Veteran, he will be missed but never forgotten. Always loved and will be forever missed.

Steve Orders (1970)

Steven Paul Orders, 70, of Cleveland, Tennessee, passed away on 28 September, 2020 and was interred at Chattanooga National Cemetery with full military honors. He is survived by his wife, Penny Theresa Lawson-Orders.

SSG Steve Orders was an honor graduate of the Non Commissioned Officer Candidate School at Fort Benning, Georgia. He was assigned to Bravo Company, 3rd Battalion, 22nd Infantry while we were in Cambodia, but was held in the rear until the Battalion returned in mid June,1970. When I first met Steve, I was impressed by his calm demeanor and professional attitude, though he was only 20 years old. He did express to me his concern that he might somehow fail the men he would lead in combat. I tried to reassure him that although no one could predict the future, I felt that his training and instinct would sustain him.

Steve soon replaced SSG Roger Ponn as the 1st Platoon Sergeant and, in the absence of an officer, he was also the acting Platoon Leader. The 3/22nd relocated to Xuan Loc in late August. On August 31st Bravo Company was conducting a reconnaissance mission in the dense jungle east of Saigon. The 1st Platoon was in the lead. Steve recalled the events of that day.

"The point element crossed a stream and saw signs of enemy activity. As we moved ahead, my platoon crossed the stream and the point element made contact. I lost radio contact with the CO (Captain George Baxter) so I decided to secure the area. I sent Gary Metz, James Duckworth and Fred Henriksen upstream and I took three men downstream. Small arms fire came from upstream but I could not discern if it was M-16 or AK-47. Instinctively I moved toward the gunfire. Fred Henriksen met me and was going into shock. He could not speak, only point in the direction of Metz and Duckworth. I came to a small clearing and saw Metz and Duckworth lying face down beside freshly dug bunkers. Not knowing their condition, I reacted ...moving toward them. I took one step headed to check on the closest man, then came another 3 round burst of AK-47 fire and I was shot. The next thing I remember was lying on the jungle floor trying to get my breath. A bullet went in the left side of my neck and severed my spinal cord; it excited at my right shoulder blade. Captain Baxter arrived and began laying down M-60 fire. Rockets were blasting the trees sending shrapnel like wooden bullets throughout the area. I was struck again in my left eye."

Continuation of Steve Orders Eulogy

Tim Wuethrich and Medic Alexander Waters crawled forward under fire to assist Steve, and Tim was also wounded. They were able to pull him back to be medevac'd. A Jungle Penetrator was required due to the triple canopy. Steve was unable to hold on so Tom Romeo wrapped his body around him as they were hoisted skyward to safety. On hearing the reports of the contact (I was then the Battalion S-2), I went to the Evacuation Hospital but by the time I arrived Steve was lying unconscious on a gurney in the hallway. I did not know the extent of his injuries or the status of his treatment. I left Vietnam and the Army five weeks later and on the day I departed there was a helicopter crash that took 5 more men from Bravo Company. I went home not knowing their names. I also did not know if Steve had survived his wounds.

Fifteen years later I heard a public service announcement on the radio with the speaker identifying himself as Sergeant Steve Orders of the Disabled American Veterans. At first I thought that might just be a pseudonym like Sergeant Rock or Captain America, but it prompted me to try to determine if that really was Steve. The task took another 12 years. When I first called Steve in 1997, I asked how he was doing. He said he was okay but had to visit the VA Hospital in Chattanooga because of deterioration of cartilage in his neck. His exact words were, "I sneezed and broke three bones." So nonchalant—I could not even begin to imagine the challenges he had faced all those years. We met in Washington D.C. later that year at a Charlie 3/22 reunion. Fred Henriksen and Jerry Malone from 1st Platoon were also there, but Steve had driven himself alone. After we all visited in the lobby I asked Steve if we could meet in private and we did later that afternoon. I did not inquire about 31 August but he did share some details about his medical treatment and the transport back to the United States. My main concern was how he had managed to deal with the effects of his wounds and cope with living as a paraplegic. He said simply, "Sometimes it is a little inconvenient."

I have kept in touch with Steve over the years and I had made plans to visit on my way to the North Carolina reunion in 2020. Our last email exchange was just a few months ago. He told me then, "My post injury reentry was through the medical system and I was out of rehab in September 1971. It was only then that I learned that Metz and Duckworth were killed. I don't think I would have survived had I known they died under my direction that day. I do not have regrets regarding my service. I do regret the politics that got us all there. I have been relatively healthy until the last 4 years. Don't know how much longer I have. I'm not afraid of dying, but I hate the suffering until I do. If all goes well, I will see you when you get closer. Let me know of your plans to be in the area."

Steve Orders survived another 50 years after Vietnam and in his mid-50s, he and his wife, Theresa, adopted a premature infant who has grown into a fine young man under their love and guidance. Steve was paralyzed from the chest down, and lost a lung, an eye and partial use in one arm due to his wounds, but lived a full and productive life inspiring others by his faith and resilience.

His widow, Theresa, wrote me recently on coping with the loss. "Steve is the love of my life and since we first met all those years ago we have been inseparable. He is one of the finest people I've ever known. I have always called him my Angel on Wheels because that's exactly what he is. He would give you everything he has and has done this through the many years I've known him. Steve told me when he was wounded the Lord started revealing Himself to him. He said he remembers thinking that he sure hoped that the Jesus he learned about in Sunday School was real and the Lord took over. That was not the end of Steve's story but only the beginning. Miracle after miracle started happening to him. It was evident that God had a plan for him and the miracle of him being able to leave that jungle floor was only the beginning the testament his life took that day. Steve has lived for the Lord, not just words but actions. He has truly lived for God and everyone who knows him can attest to this as his truth. How could I not fall in love with this man?"
