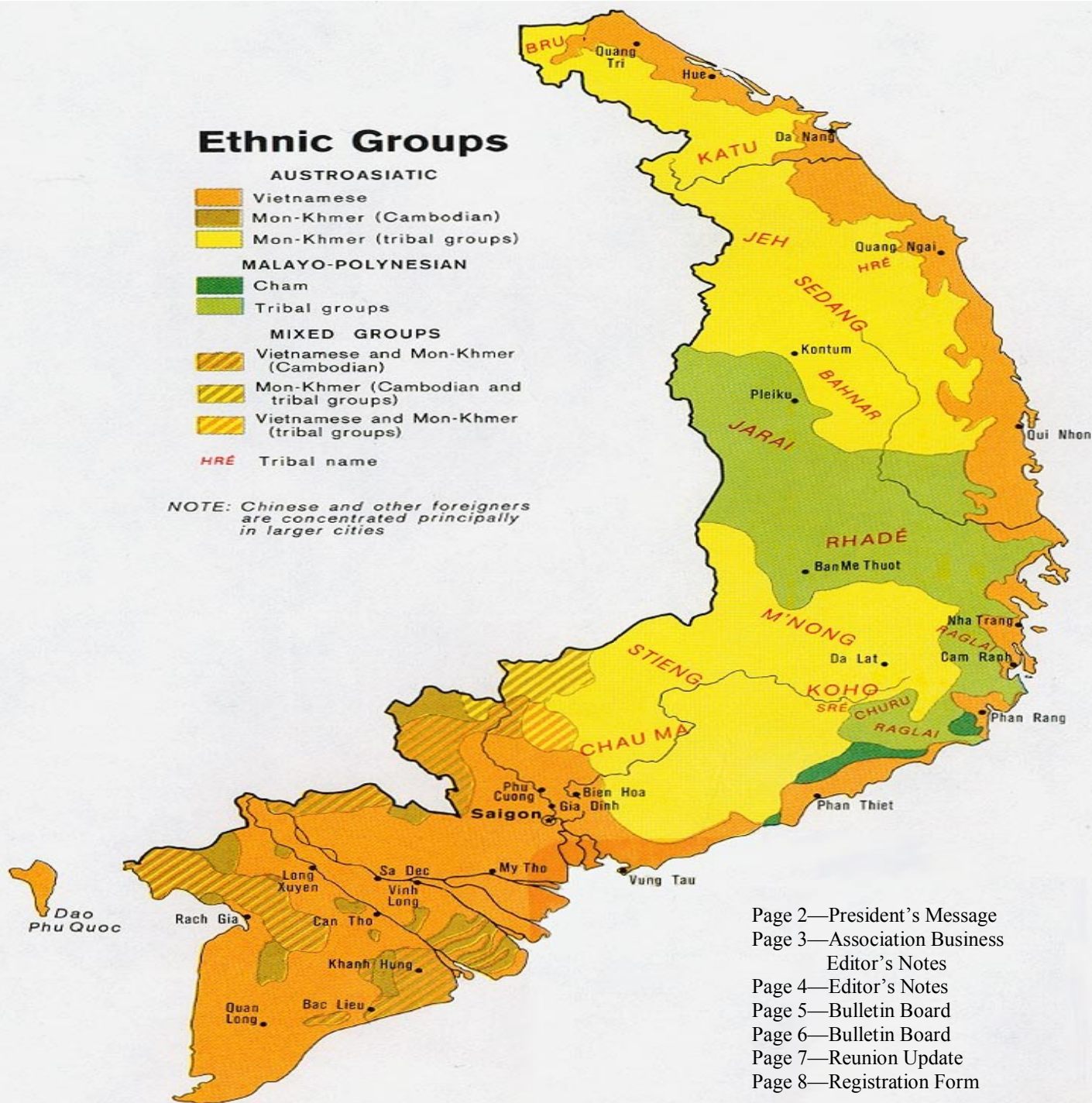

As I've reported previously, I volunteer at the Virginia War Memorial twice a month and was asked to participate again this year in its annual Vietnam seminar, which involved veterans sharing their experiences with high school students from across the state. Upon arrival at the Memorial, I was given a packet for the day's activities which included the button pictured. After seeking the source of the button, contact was made with the Department of Defense. They advised that a law was passed in 2008, where the Department was directed to facilitate organizations to assist the nation in honoring



Vietnam Veterans upon the commemorative 50th anniversary of the conflict. I was asked to have Bravo Company join with over 7,000 organizations nationwide to become a Commemorative Partner, which would involve seeking to honor all Vietnam Veterans through outreach programs and other activities. Bravo Company first became involved in the war with its activation fifty years ago this year. By its very existence and reunions every two years, as an inclusive organization, we reach out and honor all our members for the contributions they have made in the service of our nation. We will take part in an initial commemorative event at Ft. Carson where General Jack Vessey will address those who participated in the Battle of Suoi Tre, forty-eight years ago. We'll hold our own event at our reunion hosted by Richard Ward in Naples, Florida in April of 2016, just about a year from now. Not wishing to seem cynical, it does seem that the honor being directed toward us is a little bit late in coming. **Submitted by Editor—Reprint from The Ivy Leaves, December 2002—re: John Kapor**

It all started with a letter "Greetings from the President of the United States" around Thanksgiving Day, 1965. By December 10, I reported to the Induction Center in downtown Chicago. After a brief reception at Ft. Polk, Louisiana, we were assigned our final destinations for Basic Training. I was on my way to Ft. Lewis, Washington. On January 2, 1966, I started basic training with B Co 3/22 Infantry, 3rd platoon. After returning from basic training leave, my platoon Sgt. Doberman told me to get my gear together as I was being assigned to HHQ 3/22, "Davy Crockett" platoon, which I thought at the time was a "joke". It was no "joke" as I was soon to learn. S/SG Catron was our platoon instructor. It was a "nuclear weapon system". After "someone" determined they were not going to use nuclear weapons in Vietnam, all the personnel were reassigned to other units for further training. I was attached to HHQ 3/22 under Captain Bray. I was with Recon, 106 recoilless rifle, Lt. Goff, platoon leader. Then I trained on the 81-mm mortar. After leave before going to Nam, I was assigned to A Troop 1/10 Cavalry, 4.2 mortar track #29. On June 14, 1967, I was wounded and my squad leader Sgt. Montoya was killed and posthumously awarded the Silver Star. I was hospitalized for 13 months (6 months at Great Lakes Hospital in Illinois and then 7 months at the Fitzsimmons Hospital in Denver, Colorado) and finally medically retired from the Army. After all these years, I came in contact with my former Captain and 1st Sergeant who recently wrote affidavits in support of my Bronze Star with "V" device which I received on 7-13-01. In closing I want to say I was spared the "Real Horror of War" that my basic training buddies experienced at "Suoi Tre". "Unwanted or Just Lucky?" - you be the judge, I personally know which one I am.

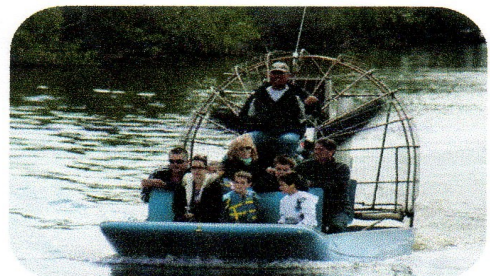
